I am currently homeless at a room and board care facility with 11 other housemates here. Two persons are in their 90s, two persons crippled in wheel chairs and one person fully deaf.

I've been here for over a year with no luck at obtaining market rate housing for a studio apartment at my affordable rate on a fixed social security disability income.

For various reasons, my efforts are dashed one way or another due to my being squashed and a lifetime ban against services rendered unjustly against me with a lifetime ban against services. The 401(c) non profit is the one in the wrong here and they refuse to reconcile the truth

Here is my latest CD4/CD8 ratio test at provider Kaiser Permanente. My case manager at Kaiser Permanente when she gets back from her winter vacation is going to draft a hardship letter effectively for an interface with Lutheran Social Services. They too are a HOPWA managing agency listed with the same Bernardino county housing authority.
